Acceptable Use and Responsibility Policy
for Electronic Communications

Our vision for the use of technology for any individual, including student, minor, and adult, who is a participant in any STA's ministry, is as follows:

We seek to connect and interact with all participants in our ministries through the effective implementation of technology. STA believes that all participants in our ministries should have access to technology when they act in a responsible, efficient, courteous and legal manner.

Responsible uses of technology are devoted to activities that support the mission of STA Parish. The following statements signify our agreements about the use of technology for those who participate in STA ministries:

As a participant in a ministry at St. Thomas Aquinas Catholic Church... ● I will not harm other people or their work.

- I will not interfere with the operation of the network.
- I will respect copyright laws. I will properly cite sources.
- I will not seek, view, send, or display offensive messages or media.
- I will not share my passwords with another person or ask another person for their passwords.
- I will not waste limited resources such as disk or server space, bandwidth, or printing capacity.
- I will not trespass in another's folders, work, or files.

- I will notify my teacher, adult group leader, chairperson or a trusted adult immediately if by accident I encounter materials that violate the rules of responsible use.
- I will not use any form of electronic communication to harass, intimidate, or bully anyone. Any form of bullying or harassment will result in immediate suspension from the program. Repeated issues with bullying/harassment will result in removal from the Parish program.
- I will not attempt to access the Internet via any connection that bypasses St. Thomas Aquinas Catholic Church's firewall and Internet content filters. This includes cellular service through wireless service providers.
- I will not watch videos, listen to music or play games on my iPad during class/meeting hours without teacher permission.
- I understand that my electronic communications at St. Thomas Aquinas Catholic Church are not private and can be monitored by the Parish staff.
- I understand that I am not allowed to take photos or videos of others in the Zoom session without the consent of the instructor/group leader.
- I understand that I am not allowed to record Zoom lessons or activities without the permission of the instructor/group leader.
- I understand that these expectations of responsible use apply to any and all times I am in the care of St. Thomas Aquinas Catholic Church.
- I am prepared to be held accountable for my actions, for the loss of privileges, or may experience other appropriate consequences if these rules are violated.

Monitoring and Infractions

To ensure the safety of the participants in STA ministries, the use of Zoom is limited to learning, prayer, Bible Study, or group meeting purposes. Those who are off task or who choose to violate this AUP will be subject to progressive disciplinary action, including the following:

- First Infraction: parent meeting / meeting with group leader/instructor
- Second Infraction: parent meeting / meeting with group leader/instructor and Father John or Father Justin

NOTE: Multiple or serious infractions or willful disregard of rules may result in suspension or removal from the Parish program/ministry.
